**SUBJECT: STATUS UPDATE OF THE KENYA SCOUTS ASSOCIATION**

It is my prayer that you are all continuing with the noble role calling of shining the light of Scouting to create a better world that all of us, the young and the old can be happy to live in.

The Kenya Scouts Association is currently experiencing a minor disruption in its operations following a police enforcement of a court order meant for the National Scout Council but served on the Secretariat. Kenya Scouts Association, being a law abiding organization, may not have agreed with the interpretation and the manner in which the court order was served but it chose to obey and closed the HQ offices temporarily to let our legal consultants handle the matter in court.

In the meantime, as your Chief Commissioner, I want to reassure you that the Kenya Scouts Association remains intact and our Scout leaders should continue to support our Scouts all over the country to enjoy the game of Scouting without a hitch. The Kenya Scouts Association is an organization founded by Act of Parliament, and has a Constitution, policies and regulations that govern its operations and how leadership positions are assumed.

Kindly ignore any communication that you get from any unofficial sources to the effect that KSA is either closed or has been taken over by anybody or any group of people. The leadership of the Association has not changed one bit. The National Scout Board remains fully in charge as mandated by the Constitution.

This circular is meant to reassure you that all is well within the organization and whatever minor disruptions being experienced will be professionally and swiftly handled by the Chief Commissioner and the National Scout Board.

I will continue to update you as is appropriate.
